I agree to reimburse Nordic Mountain, LLC for any loss or damage of any kind to the rental equipment other than reasonable wear and tear. I agree to return all rental equipment on the agreed upon date, in clean condition, to avoid additional charges.

I have made no misrepresentations to Nordic Mountain, LLC in regard to my height, weight, age, or skiing ability. All instructions on the use of my rental equipment were made clear to me and I understand the function of my equipment.

I agree that the equipment will be used for purpose of skiing at Nordic Mountain only. I agree there are no warranties, expressed or implied, which have been made to me concerning the ski equipment, and I accept the ski equipment in its AS IS condition.

RELEASE OF LIABILITY: I accept and clearly understand that there are inherent and other risks, dangers and hazards associated in the sport of skiing for which this equipment is to be used which can result in serious personal injury or death and that injuries are a common and ordinary occurrence in this sport. I FREELY ASSUME ALL RISKS OF INJURY OR DEATH ASSOCIATED WITH THE SPORT OF SKIING. I further recognize and acknowledge that the risks inherent in the sport of skiing can be greatly reduced by taking lessons, abiding by the Skier Responsibility Code (Known as Your Responsibility Code), and using common sense.

I understand that the boot/binding system which I have rented is designed to reduce the risk of certain injuries to the lower leg. It will not release at all times, nor under all circumstances where a release may prevent an injury, nor is it possible to predict every situation in which it will release, and therefore does not guarantee my safety.

I further agree and understand that although the boot/binding system, which I have rented, may reduce the risk of certain injuries to the bones of my lower leg, it will not at all reduce the risk of injury to my knees or other parts of the body.

I further understand that the boot/binding system which I have rented does not have a backwards release capability, and therefore will not release or protect any part of my body in the event of a backwards fall.

I, the undersigned, in consideration of the rental of the equipment by Nordic Mountain, LLC hereby RELEASE AND FULLY DISCHARGE Nordic Mountain, LLC, its owners, agents, and employees from any and all liability resulting from personal injury to myself or damage to my property which is caused in any way by the NEGLIGENCE of Nordic Mountain, LLC or any of its owners, agents, or employees in the installation, adjustment, inspection, maintenance and/or rental of the equipment, and/or in the instructions given or not given to me concerning the equipment and its use, and/or from my use of this equipment. I accept full responsibility for any and all injuries or damages of any kind which may result from the use of the ski equipment and it is my intention to HOLD Nordic Mountain, LLC, its owners, agents, and employees HARMLESS for any injury sustained by me while using the above described ski equipment.

In the event that I am signing as a parent of a minor, I represent I have full authority to do so, realizing this release is binding upon the minor as well as myself.
